## FIELD TRIP RULES

Dear Parent:

Field trips are exciting and a great deal of fun for all involved as long as everyone follows the safety rules. Please take a moment to go over these safety rules with your child/children.

### BUS RULES

1. Listen to the bus driver. (He/She takes extensive training in bus safety.)
2. Keep your seatbelt on at all times.
3. No eating or drinking on the bus.
4. Only remove seatbelts when told to do so by the driver or counselor.
5. No yelling on the bus.

### FIELD TRIP RULES

1. All children must have the signed field trip permission form on file with the office.
2. Each child must wear his/her Hudson t-shirt. (If a child is not wearing his/her t-shirt on the day of a trip, a shirt will be given to the child, and the parent will be charged \$10 for the cost of the t-shirt.)
3. All children **must** stay with his/her group.
4. All children **must** respect the rights of other children.
5. Children **are not** allowed to purchase souvenirs and/or food items, unless otherwise told by the child's counselor or the camp Director.
6. Each child is responsible for his/her personal property brought on the trip (please keep valuables at home). Hudson is not responsible for lost, stolen or broken personal property.

Please post the field trip rules on your refrigerator, and review them with your child before each trip.
